Issue

We misunderstood the deadlines for ad placement and were not able to appropriately warn the public hearing for 8/31. This is my fault. Unfortunately, we need to hold a special meeting to re-warn the public hearing for a date that we can appropriately warn it.

Discussion

The soonest we can place an ad in a publication is Tuesday, 8/23. That would be for the Burlington Free Press, which is more expensive than Seven Days, which is what we usually use. An ad could go in Seven Days on Wednesday 8/24. The good news is that once the ad is placed, all applications must be reviewed with the current and proposed updates, even though they have not gone through the public hearing or post 21-day period before they officially take effect. The ad must be place at least 15-days prior to the public hearing.
