CALL TO ORDER 1.

In the absence of David Nistico, John Alden facilitated the meeting and called it to order at 6:01 PM.

There were no announcements or disclosures.

2. **AUDIENCE FOR VISITORS**

There were no comments from the public at this time.

3. **ADDITIONS/AMENDMENTS TO THE AGENDA**

There were no additions or amendments to the agenda at this time.

4. **MINUTES**

April 4, 2019

Minutes from the April 4, 2019 meeting were not available for review. A motion to approve the April 4, 2019 minutes was tabled until a subsequent meeting.

5. PUBLIC MEETING

A. Review Comprehensive Plan Updates:

Melanie Needle, CCRPC Senior Planner, led a discussion on updates to the Village's Comprehensive Plan. The Planning Commission reviewed an entirely new draft of the Comprehensive Plan, a summary of all changes made to the Comprehensive Plan to date, a current draft of the enhanced energy plan, and updated maps.

Melanie Needle outlined accompanying documentation that staff have drafted for the Comprehensive Plan updates, which include:

- 1. A memo to planning/zoning commissions in adjacent communities (South Burlington, Town of Essex, Williston) as well as the Regional Planning Commission, Department of Housing/Community Development, to notify them that the Village is amending its Comprehensive Plan and will warn a public hearing on updates to the plan on May 23, 2019;
- 2. A public hearing notice, to be posted in the Village, which summarizes the proposed changes to the 2019 Comprehensive Plan, proposed Enhanced Energy Plan, and updated maps;
- 3. A Planning Commission report, which is required by statute and will be included in the notice when warning the public hearing on plan updates. This report outlines each statute requirement and how the updates to the plan meet these requirements. The report will be shared with adjacent communities at least 30 days prior to the public hearing.

Melanie Needle outlined the latest changes to the Comprehensive Plan, as follows:

- All data has been updated except for Table 11 in transportation section, which will be updated for the public hearing draft;
- All references and narratives have been included for studies (Green Streets Guide, Forest Integrity Requirements, Five Corners Design Study, Bike Pedestrian Plan, River Corridor Requirements);
- All recommendations from draft parking study and tactical basin plans have been incorporated;
- Education section has updated to reflect Essex/Westford School District, and additional information from school district that will be included in next draft;
- Enhanced Energy Plan has been drafted and has incorporated changes from the last meeting;
- Land Use section updated to reference neighborhood development area designation;
- Language has been added to the Plan regarding the following:
 - Accelerate Essex (incubator space in the Village)
 - o Discussion of tourism as part of economic development in the Village
 - Public health discussion in Open Space Parks section
 - Historic preservation in the Village Center (balancing historic preservation and economic vitality).

Melanie Needle led a review of outstanding topics and components in the Comprehensive Plan, including the Housing and Land Use objectives and the implementation schedule. Minor adjustments were made to both the Housing and Land Use objectives language. Melanie Needle noted that she will ensure that any modifications made to goals or objectives are reflected in the implementation schedule. She will also propose how to fit new objectives into the implementation timeline for the draft to be reviewed at the public hearing. She also noted that as the public process continues, the Planning Commission can make modifications as needed.
